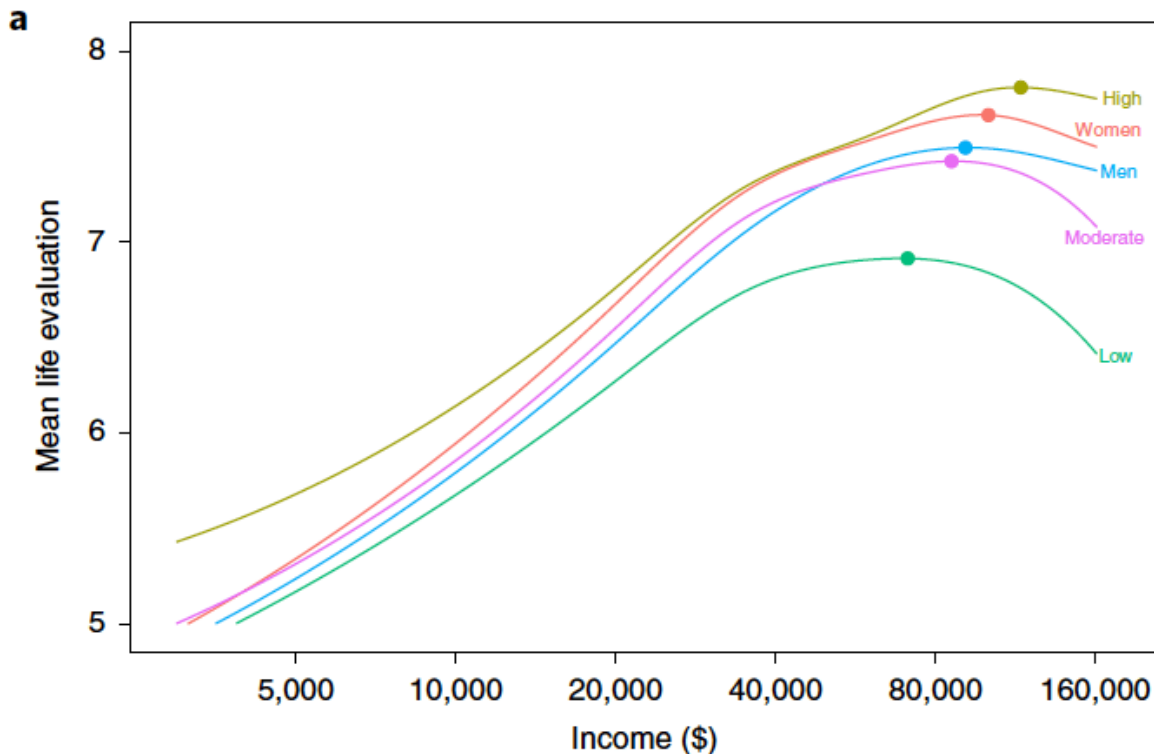

U N Resolution on happiness and monetary turn of events

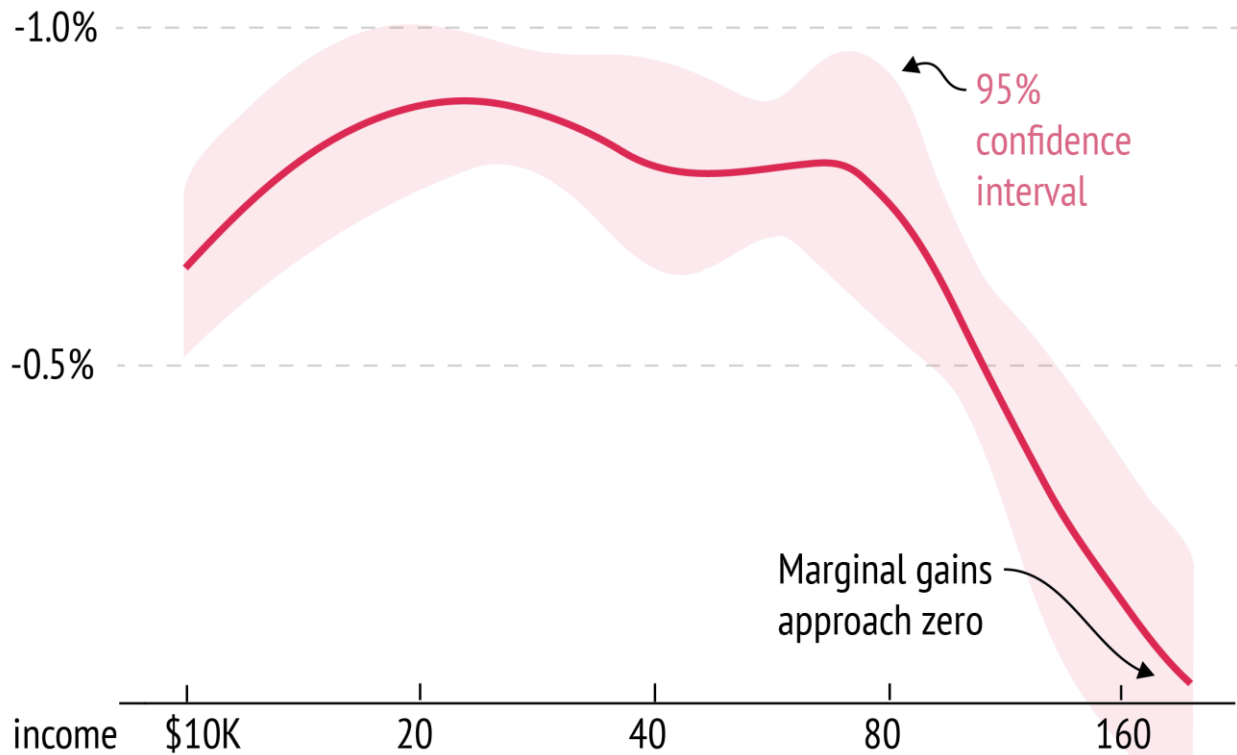
